



## The Wall: Haul of Cash Competition Terms and Conditions

By entering the “**The Wall: Haul of Cash Competition**” (“the Competition”), you are agreeing to the following terms and conditions:

### **1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

### **2. WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is open to all residents of Australia where the Channel Seven and its affiliated networks (“Affiliates”) signals are received. Entry is open to people aged 18 years and over.

2.2 Employees (and their immediate families) of Seven Network (Operations) Limited, Ansible Pty Ltd, and their associated agencies and companies are not eligible to enter.

### **3. PRIZE MECHANIC**

3.1 The Wall Haul of Cash gives viewers of episode one (1) of the program the chance to win a Major Prize of one hundred thousand dollars (\$100,000.00), or a chance to win a share of the Minor Prize of one hundred thousand dollars (\$100,000.00).

3.2 In order to win the Major Prize of one hundred thousand dollars, a viewer must obtain the sole Major Prize winning game card, that has been printed and inserted at random into one of the participating newspapers, as listed in Clause 4.2, and redeem within the competition period. The Major Prize winning game card must match all 7 balls in exact order of the competition segment. Only one Major Prize winning gamecard will be available nationally.

3.3 In addition, the Major Prize winner will be invited to participate in a second game of chance to win up to an extra one million dollars (\$1,000,000.00). (making the total prize to that winner one million, one hundred thousand dollars (\$1,100,000.00)).

3.4 There will be one hundred and thirty (130) minor prize winning gamecards printed and inserted into the participating newspapers, sharing in an additional minor prize pool of one hundred thousand dollars (\$100,000), as outlined in Clause 5.2. All Minor Prizes must be redeemed in the competition period.

3.5 Participants have a One (1) in Thirteen Thousand Six Hundred and Sixty Five (13,665) chance of winning a prize.

### **4. HOW TO PARTICIPATE**

4.1 The Competition commences at the beginning of Episode 1 of “The Wall” scheduled for **Monday 30 October 2017 at 19:30 AEDT** and concludes on **Wednesday 1 November 2017 at 19:30 AEDT** (“Competition Period”). Winners must redeem their prize by Wednesday 1 November 2017 at 19:30 AEDT. In the event of schedule changes, the new dates will be communicated via all marketing channels, subject to State regulations.

4.2 In order to participate, participants must purchase The Sunday Telegraph in New South Wales and ACT, The Sunday Herald Sun in Victoria, Sunday Tasmanian in Tasmania, The Sunday Mail in Queensland, Sunday Mail in South Australia, Sunday Territorian in Northern Territory and The Weekend West in West Australia on sale Saturday 28 & Sunday 29 October 2017 to receive their “Gamecard” for episode 1 of the Program. “Gamecards” are the cards distributed to participants and used to determine winners of the Competition.

4.3 In order to determine whether they have a Gamecard which entitles the participant to a Prize (a “Winner Gamecard”), participants with a Gamecard may watch The Wall (‘The Program’) on the Seven Network and regional affiliates on Monday 30 October 2017 (episode 1).

4.4 Gamecards will be printed to indicate 7 bold and/or shaded numbers per gamecard, printed in a row horizontally.

4.5 A Gamecard is a Prize Winner Gamecard if the bolded and/or shaded numbers included on the card are called during the promotion segment of episode 1 of the Program. Prize Winner Gamecards show either 4, 5, 6 or 7 numbers matching the order they appear in the episode. In the event of any uncertainty of whether a

Gamecard is a Prize Winner Gamecard, Prize Winners are determined at the Promoter's sole discretion by reference to the unique code printed on the Gamecards.

4.6 Holders of Prize Winner Game Cards must redeem their winning cards within the competition period, as described at Clause 6.

4.7 There will be Competition pointers aired during episode 1 of the Program (subject to Programming changes), during which participants will be invited to check whether they have a Prize Winner Gamecard by checking the numbers announced in the Program with the numbers printed in bold and/or shaded on their Gamecards.

**5. PRIZES**

5.1 There will be **one hundred and thirty one (131)** prize winners comprising, **one hundred and thirty (130)** Minor Prize Winner Gamecards and **one (1)** Major Prize Winner Gamecard. The prizes are set out in clause 5.2.

5.3 The Major Prize Winner will be invited to participate in Game 2 - a Game of Chance with the opportunity to win up to an additional One Million Dollars (\$1,000,000.00).

5.4 Cheques will be made payable to each Winner to the value of the prize won.

5.7 Prizes are not transferable or exchangeable.

5.8 Independent financial advice should be sought as tax implications may arise as a result of accepting the prize.

If accepted, the winner grants the Promoter and the Prize Provider a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide and the winners will not be entitled to any fee for such use.

## 6. **HOW TO REDEEM**

- 6.1 Prize Winner Gamecard holders must visit the website [www.yahoo7.com.au/TheWallWin](http://www.yahoo7.com.au/TheWallWin) and register their:
- (i) Unique code,
  - (ii) Name,
  - (iii) Daytime telephone number (including STD area code),
  - (iv) Email address; and
  - (v) Street address (including postcode)
  - (vi) Confirmation of age
- to redeem their Prize.
- 6.2 Each Prize Winner Gamecard can only be redeemed once. In the event a winning gamecard is registered more than once, evidence of the winning gamecard will be requested by a Seven Network representative.
- 6.3 All Prize Winner Gamecards will need to be redeemed by **Wednesday 1 November 2017 at 19:30 AEDT** or the prize is forfeited. After this date no further claims can be made.
- 6.4 Additionally, in order to redeem the One Hundred Thousand Dollar Major Prize (\$100,000.00) prize and participate in Game Two for the chance to win an additional One Million dollars (\$1,000,000.00), the participant will need to present the physical winning gamecard to their closest Channel Seven Head Office by **Friday 3 November 2017 at 17:00 AEDT**.
- 6.5 All Gamecard holders can verify whether their card is a winning Gamecard by entering the unique code details at [www.yahoo7.com.au/TheWallWin](http://www.yahoo7.com.au/TheWallWin), plus enter their details to participate in the second chance draw, if one is required.
- 6.6 A member of the Seven Network Marketing department will contact the winners by a phone call within 5 business days of the registration (as outlined in Clause 6.1) and a letter advising the winner of their prize will also be posted with their cheque. Winners' entry details will be published in the Public Notices section of The Australian newspaper on Monday 13 November 2017.
- 6.7 The Major Prize Game 2 Game of Chance will comprise of the Major Prize Winner participating in a game of chance by selecting One (1) out of One Hundred (100) balls which will all contain a pre-determined prize value.
- 6.7 a) There will only be one (1) opportunity to select an item for this game.
  - 6.7 b) Ninety Nine (99) items will contain the prize value of One Thousand dollars (\$1,000.00), and one (1) item will contain the prize value of One Million dollars (\$1,000,000.00).
  - 6.7 c) Whichever prize value is detailed in the randomly selected item will be the Australian dollar amount that the winner will receive.
  - 6.7 d) The major prize winner may nominate one immediate family member (a spouse, de facto partner, child, parent, grandparent, grandchild or sibling of the major prize winner) to act as a proxy in this game of chance and participate in lieu of the major prize winner if they are not unable to attend. If the major prize winner cannot nominate an immediate family member to participate in this game of chance, the major prize winner will be deemed ineligible and a redraw will occur at the discretion of the Promoter
  - 6.7 e) The Promoter will cover transfer costs to and from the major winner's place of residence to their local Seven office to a maximum of two hundred dollars (\$200.00).
- 6.8 In the event that the Major Prize and all Minor Prizes are not claimed, all registrants (as per Clause 6.5) will be entered into a second chance prize draw to distribute the unclaimed prizes.
- 6.9 The second chance draw for all unclaimed Minor or Major Prizes will be held at Ansible Pty Ltd, Level 1, 16 Anster Street, Adelaide, SA, 5000, on Monday 6 November 2017 at 11:00 AEDT.
- 6.10 Minor Winners' of the second chance draw will be contacted by phone within five (5) business days and a letter advising the winner of their prize will also be posted with their cheque. Second Chance Draw Winners' details will be published in the Public Notices section of The Australian newspaper on Monday 20 November 2017.
- 6.11 The Major Prize Winner of the second chance draw (if required) will be contacted by phone within two (2) business days. The Major Prize Winner of the second chance draw will be invited to participate in Game 2 for the chance to win up to an additional one million dollars (\$1,000,000.00).
- 6.12 The Promoter's decision is final and the Promoter will not enter into correspondence regarding the result.
- 6.13 The Promoter may in its absolute discretion deem entries invalid subsequently to a winner being notified or a winner's name being announced if it is deemed at the Promoter's absolute discretion that the winner did not enter the Competition in accordance with these terms and conditions, including but not limited to unlawfully accessing a Prize Winner Game Card.
- 6.14 It is a condition of accepting the prize that the winner (and parent or legal guardian) may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.

## 7. **NOT A GAME OF BINGO**

- 7.1 The Program is pre-recorded and therefore participants are not playing a game of 'Bingo' or 'Housie' as regulated by applicable legislation, rather participants are entering a trade promotion lottery (the

"Competition"). The winning numbers are known by the Promoter before the Gamecards are printed and distributed. As such the draw/display of numbers during episode 1 of the Program has no effect on a participant's chances of winning. A set number of Prize Winner Gamecards will be distributed by, or on behalf of, the Promoter. The element of chance affecting a participant's chance of winning is the random distribution of printed Gamecards.

## **8. NO LIABILITY**

- 8.1 In the case of the intervention of any outside act, agent or event which prevents or significantly hinders the Promoter's ability to proceed with the Competition on the dates and in the manner described in these terms and conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism, the Promoter may in its absolute discretion cancel the Competition and recommence it from the start on the same conditions, subject to state government legislation.
- 8.2 Seven Network (Operations) Limited, Ansible Pty Ltd and their associated agencies and companies will take no responsibility for prizes damaged or lost in transit, or late, lost or misdirected mail.
- 8.3 Seven Network (Operations) Limited, Ansible Pty Ltd and their associated agencies and companies will not be liable for any misadventure, accident, injury, loss (including but not limited to consequential loss) or claim that may occur:

  - b) in the participation, acceptance or use of any element(s) of the prize;
  - c) as a consequence of late, lost or misdirected mail;
