#### Terms and Conditions

By entering the Sunrise 'Married in the Morning' Fiji Competition, you are agreeing to the following terms and conditions:

#### 1. **STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

#### 2. **WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is open to all residents of Australia over the age of 18 years old where the Channel Seven signal is received.

2.2 Employees and their immediate families of Seven Network (Operations) Limited, Shangri-La Hotels, Vomo Island, Fiji and their associated agencies, sponsors and companies are not eligible to enter.

#### **HOW TO ENTER**

The competition commences on Monday 9 April 2018 at 7.00am AEST and concludes on Monday 30 April 2018 at 12.00pm AEST.

In order to enter the competition, viewers must watch Sunrise ("the Program") on the Seven Network between Monday 9 April 2018 and Monday 23 April 2018 (inclusive) where Sunrise will promote the Competition on selected days during the Competition Period.

- 4.14 The reception location will be chosen by the Sunrise production team, the Shangri-La Hotel Fiji and is at their total discretion. Final decision regarding all decoration, theming, set up, locations and visual items is at the sole discretion of the Shangri-La Hotel Fiji and the Sunrise production team. Further terms and conditions apply and are available on request.

#### **Flights**
