



**CHANNEL SEVEN
NOMINATE YOUR SUBURBAN SUPERSTAR COMPETITION
TERMS AND CONDITIONS**

By entering the “Suburban Superstar Competition” (the “Competition”), you are agreeing to the following terms and conditions.

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms and conditions of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to residents of Australia over the age of 18, where the Channel 7 and affiliate broadcasting signals are received.

2.2 Employees and their immediate families of Seven Network (Operations) Ltd, Australia Post and their associated agencies and companies associated with this promotion are not eligible to enter.

3. HOW TO ENTER

3.1 The competition commences on **[date]** and concludes on **[date]** (“the Competition Period”).

3.2 The Competition will be promoted on the Sunrise website www.yahoo7.com.au/sunrise and also promoted within the Sunrise program.

3.3 In order to enter, viewers must:

(a) watch Sunrise (“the Program”) on the Seven Network during the Competition Period. During the Competition Period there will be a competition segment aired during the Program, in which viewers will be invited to log onto the Sunrise website (www.yahoo7.com.au/sunrise/suburbansuperhero).

(b) nominate their Suburban Superstar by telling us in 150 words or less why they deserve to be awarded the Sunrise Suburban Superhero together with the entrants full name, full residential address (including postcode), a valid email address and telephone number.

3.4 The entry must be:

- a) the original independent creation of the entrant; and
- b) free from any claims, including but not restricted to copyright or trademark claims, by other parties.

3.5 Any cost associated with accessing the promotional websites is the entrant’s responsibility and is dependent on the Internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.

- 5.5 Once details are confirmed, the Suburban Superstar will receive written confirmation of their prize. The Suburban Superstar's details will be published on the Sunrise website from [date].
- 5.6 The Promoter's decision is final and the Promoter will not enter into any correspondence regarding the result.

6. NO LIABILITY

- 6.1 In the case of the intervention of any outside act, agent or event which prevents or significantly hinders the Promoter's ability to proceed with the Competition on the dates and in the manner described in these terms and conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism, the Promoter may in its absolute discretion cancel the Competition and recommence it from the start on the same conditions.
