Terms and Conditions

By entering the **“Better Homes and Gardens - Blanco Kitchens Mother’s Day” Competition** (“the Competition”), you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all residents of Australia 18 years of age and older in Australia where the Channel Seven and its affiliated networks (“Affiliates”) signals are received.

2.2 Employees (and their immediate families) of Seven Network (Operations) Limited, Mnet Mobile Pty Ltd, Shriro Australia Pty Ltd and their associated agencies and companies are not eligible to enter.

3. HOW TO ENTER

3.1 The Competition commences on **Thursday 8 May 2014 at 18:00 (AEST)** and concludes on **Monday 12 May 2014 at 09:00 (AEST)** (“the Competition Period”).

3.2 For entry details, viewers must watch Better Homes and Gardens (“the Program”) on the Seven Network (“the Network”) and Affiliates during the Competition Period. There will be a competition segment aired during the Program which will display information on how to enter.

3.3 In order to enter the draw, viewers must either:

a) Send a text message/SMS to **1977 1717** and register their full name, suburb and state;

Or

b) Telephone **1902 55 77 01**, and register their name, address (including postcode) and contact daytime telephone number (including STD area code).

3.4 All entrants in the Competition may enter up to a maximum of 100 times, but only one prize will be awarded per person. For SMS entries, once the maximum of 100 entries have been received from a single mobile account, entrants will receive a reply SMS message notifying them of this limit. If it is otherwise discovered that an entrant has entered more than 100 times in total, via any entry mechanic, only the first 100 entries will be included in the draw and further entries will not be considered, nor will the cost of the entries be refunded to entrants.

3.5 For SMS entrants, each entry must be charged to a mobile account and SMS entries via the internet, computer generation or “scripting” are invalid and will not be accepted.

3.6 Entries must be received by **Monday 12 May 2014 at 09:00 (AEST)**. The time of entry will in each case be the time the SMS message or 1902 telephone call is received by the Mnet Mobile Pty Ltd database.

3.7 SMS entrants will receive a reply message to their entry.

3.8 Each SMS entry will be charged at premium rate, namely \$0.55 (including GST), which covers the entry and the reply message.

3.9 The maximum 1902 call cost is \$0.55 (including GST). 1902 call costs will be higher from mobile phones.

4. PRIZES

- 4.6 Winners will arrange a suitable delivery time and date of their chosen prize package with the Sponsor
- 4.7 The Prize Sponsor does not install the products. Installation of any portion of the prize including any ancillary or additional parts not specified in Clause 4.2 above is at the cost of the winner. In addition, the prize sponsor does not pay for any alterations needed to cabinetry
- 4.8 The winners agree they will not sell or otherwise provide their story and/or photographs to any media or other organisation.

Any applications for extended warranty periods or warranty claims are the winner's responsibility and not that of the Promoter.

- 4.13 Delivery of the Blanco products detailed in Clause 4.2 is included in the prize package and is at no cost to the winner. The winner must be available to take delivery of the product within business hours
- 4.14 In cases where winners are unable to install products that require a gas connection, the Prize Sponsor will exchange the gas product for the equivalent electric product.

5. HOW TO WIN

- 5.3 The Promoter's decision is final and the Promoter will not enter into correspondence regarding the result.
