

"Hercules" Competition

Terms and Conditions

By entering the "Hercules" Competition (the "Competition"), you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

- Subject to clause 2.2, entry is open to all residents of Australia. If the Major Prize Winner is under the age of 18, he/she must be accompanied by an adult over the age of 18 when taking the Major Prize. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Competition.

3. HOW TO ENTER

- The Competition commences on Friday, 11 July 2014 at 10:00 (AEST) and concludes on Friday, 25 July 2014 at 17:00 (AEST) (the "Competition Period").
- In order to enter, users must log-on to www.yahoo7.com.au/hercules and register their name, address (including postcode), daytime telephone number and email address, and answer the following question in 25 words or less:

"Why is Dwayne Johnson the ultimate HERCULES?"

- 3.3 The entry must be:
 - a) the original, independent creation of the entrant that has not previously been published in any form in any country in the world; and
 - b) free from any claims, including copyright or trademark claims by other parties.
- Entries that are found to have been derived from another person's work in any country in the world will be considered invalid and, if awarded a Prize, that Prize must be returned to the Promoter. The Winner (or his/her parent or legal guardian, if the Winner is under the age of 18) may be required to sign a statutory declaration regarding the originality of the entry. The Promoter reserves the right to disqualify any entry it believes breaches any of these Terms and Conditions.
- Entrants agree that they are fully responsible for any materials they submit via the Competition including but not limited to comments, recordings and images ("Content"). The Promoter shall not be liable in any way for such Content to the full extent permitted by law. The Promoter may remove or decline to publish any Content without notice for any reason whatsoever. Entrants warrant and agree that:

- (a) they will not submit any Content that is unlawful or fraudulent, or that the Promoter may deem in breach of any intellectual property, privacy, publicity or other rights, defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender, not suitable for children aged under 15, or otherwise unsuitable for publication;
- (b) their Content shall not contain viruses or cause injury or harm to any person or entity;
- (c) they will obtain prior consent from any person or from the owner(s) of any property that appears in their Content;
- (d) the Content is the original literary work of the entrant that does not infringe the rights of any third party;
- (e) they consent to any use of the Content which may otherwise infringe the Content creator's/creators' moral rights pursuant to the *Copyright Act 1968* (Cth) and warrant that they have the full authority to grant these rights; and
- (f) they will comply with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and the access or use of others' computer or communication systems.

Without limiting any other terms herein, the entrant agrees to indemnify the Promoter for any breach of the above terms.

- As a condition of entering this Competition, each entrant agrees to assign all of their rights, title and interest (including copyright) in and to their entry (which shall include Content) to the Promoter, and to execute any documents to confirm such assignment. Entries will not be returned to any entrant.
- 3.7 Entrants in the Competition may enter as many times as they like, however, only one (1) entry per person per day will be accepted. Incomplete or indecipherable entries will be deemed invalid.
- The time of entry will be the time at which the completed online entry form is received by the Competition's online database. Entrants will be presented with a confirmation page once the completed email entry is submitted by the entrant. Entries received outside of the Competition Period will be deemed invalid and ineligible to enter the Competition.
- Entry details and any intellectual property subsisting in the entries become and remain the property of the Promoter and will not be returned to the entrant.
- 3.10 The Promoter reserves the right in its sole discretion to reject bulk entries which it considers to have been generated using software to generate multiple entries.

- 4.13 The Sponsor is solely responsible for the fulfilment of the Prize.

In the event that a Prize or part of a Prize is no longer available, the Promoter reserves the right to substitute the Prize (or that part of the Prize) with prize/s in its discretion to the same and equal recommended retail value.

5. HOW TO WIN

- All entries completed and submitted in accordance these Terms and Conditions will be judged at the Promoter's office at Yahoo!7, Levels 2&3 Pier 8/9 23 Hickson Road Millers Point, NSW 2000 on Friday, 25 July 2014 commencing at 17:20 (AEST). The best (one (1)) valid entry will win the Major Prize (defined in the table above). The next best sixty-five (65) valid entries will each be awarded a Minor Prize (defined in the table above). Each entry will be individually judged based on the creativity and originality of the answer provided to the promotional question. This is a game of skill. There is no element of chance in the judging of the Competition or determination of the Winners. The judges may select additional reserve entries which they determine to be the next best, and record them in order, in case of an invalid entry or ineligible entrant.
- The Winners will be notified by a phone call at the conclusion of the judging, and an email advising the Winners of their Prize will also be sent using the contact details provided in their entry.
- 5.3 The judges' and Promoter's decision (including any decisions as to Prize distribution) is final and the Promoter will not enter into correspondence regarding the result.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Competition. The Promoter reserves the right to request that the Winners provide proof of age and/or identity prior to awarding a Prize. Identification considered suitable for the verification is at the sole discretion of the Promoter. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
