

“MINIONS” PROMOTION
TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Yahoo!7 Pty Limited (ABN 60 089 187 100) of Level 2, Pier 8&9, 23 Hickson Road, Millers Point, NSW 2000 (“**Promoter**”).
3. The sponsor is Universal Pictures (Australasia) Pty Ltd (ABN 58 087 513 620) of 3 Munn Reserve, Millers Point, NSW 2000 (“**Sponsor**”).
4. Entry is only open to Australian residents aged 21 years or over who are able to attend the Minions exclusive event in Orlando, Florida (USA) on 25/08/2015 and travel on the dates nominated in clause 17, if selected as the winner.
5. Employees (and their immediate families) of the Promoter, Sponsor and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
6. Promotion commences on 12/06/2015 and closes at 11:59pm AEST on 25/06/2015 (“**Promotional Period**”).
7. To enter, individuals must complete the following steps during the Promotional Period:
 - a) visit www.yahoo7.com.au/minions;
 - b) follow the prompts to the promotion entry page;
 - c) input the requested details (including their full name, a valid email address, telephone number, and postal address);
 - d) watch the ‘Minions’ movie trailer featured on the page;
 - e) provide an answer to the promotional question “*Which of the villains shown [in the movie trailer] would you prefer to work for and why?*” in 25 words or less;
 - f) agree to the Terms and Conditions by ticking the relevant tick box;
 - g) confirm that they are aged 21 years or over by ticking the relevant tick box; and
 - h) submit the full completed entry form.
8. Incomplete or indecipherable entries will be deemed invalid.
9. Multiple entries permitted, subject to the following: (a) each entry must be substantially unique; and (b) each entry must be submitted separately and in accordance with entry requirements.
10. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
11. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

Each entry will be individually judged based on the originality, literary merit and creative merit of the answer provided to the promotional question. The judges may select additional reserve entries which they determine to be the next best, and record them in order of merit, in case of an invalid entry or ineligible entrant, or in the event the first selected entrant is unable to take the prize on the exact dates specified by the Promoter.

13. The winners will be notified by email and telephone.
14. The Promoter's decision is final and no correspondence will be entered into.
15. The best valid entry, as determined by the judges, will win a trip for the winner and three (3) companions to the Minions exclusive event in Orlando, Florida (USA), valued at up to AU\$12,446.93 depending on point of departure. The prize includes:
 - return economy airfares from winner's nearest Australian capital city to Orlando, Florida for four (4) people;
 - return transfers from the Orlando airport to the accommodation for four (4) people;
 - five (5) nights twin-share accommodation at Universal Cabana Bay Beach Resort in Orlando, with check-in on 22/08/2015 and check-out on 27/08/2015;
 - 3 Park Unlimited Universal Orlando Resort Passes for four (4) people for the duration of their stay;
 - four (4) tickets to see the Blue Man Group;
 - four (4) tickets to the Minions private event on 25/08/2015, including dinner at the Red Coconut Club at Universal's City Walk, followed by a private Minion Disco Dance Party at Music Plaza, and exclusive access to Despicable Me Minion Mayhem and Hollywood Rip Ride Rockit (exact dinner menu determined by the Promoter in its absolute discretion); and
 - travel insurance for four (4) people, up to the value of \$220.

Spending money, additional meals, taxes (excluding airline and airport taxes), insurance, passports, visas, vaccinations, transport to and from departure point, additional transfers, items of a personal nature, in-room charges and all other ancillary costs are not included. The prize must be taken to coincide with the Minions private event on 25/08/2015, with flights departing Australia on 22/08/2015 and arriving back to Australia on 27/08/2015 and is subject to booking and flight availability.
