

The Seven Network SUNRISE FACEBOOK 'ONE MILLION LIKES' COMPETITION Terms and Conditions

- 1. Information on how to enter the Promotion forms part of the terms and conditions of entry.

 - Head to the Sunrise website (<u>www.yahoo7.com.au/sunrise</u>) and enter their full name, address, contact phone number and email address to register their entry.
- 3. The competition commences on Monday 11 January 2016 at 06:00am AEDT and concludes on Friday 15 January 2016 at 11:59am AEDT. The competition will be promoted on the Sunrise website, Facebook page and on Sunrise (the Seven Network).
- 4. Entry is open to all residents of Australia where the Channel Seven signal is received.
