By entering the Sunrise Cash Cow Competition, you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms and conditions of entry.

2. WHO CAN ENTER?

- 2.1 Subject to clause 2.2, entry is open to residents of Australia, 18 years if age or older, where the Channel Seven signal is received.

- 3.2 In order to enter, viewers must watch Sunrise ("the Program") on the Seven Network during the Competition Period. Each morning throughout the Competition Period there will be a competition segment aired during the Program (or any replacement program broadcast in the Sunrise timeslot) which will disclose a code word each day.
- 3.3 In order to enter, viewers must either:
